The Certified Access Specialist (CASp) program was created with California Senate Bill 262 in 2003 and later developed further in Senate Bill 1608. The program was developed after the federal American with Disabilities Act to give the public a resource for understanding and implementing ADA regulations. The goal of the program is to provide knowledgeable resources to assist in the removal of architectural barriers causing discrimination against the disabled community. A Certified Access Specialist has the authority to inspect a building for architectural barriers and provide a report to the client. Lewis R. Springer has passed the examination process and been authorized as a Certified Access Specialist. Teamed with his architecture license and knowledge, he is able to identify architectural barriers and design solutions for architectural barrier removal.

Mr. Springer has used his certification to inspect buildings and provide reports and transition plans for building owners. He has also worked with cities to develop feasibility studies to renovate historic properties. In addition, Mr. Springer has acted as an expert witness for ADA construction related lawsuits. Mr. Springer and his team have taught workshops for commercial real estate offices, chambers of commerce, city councils, and parks and recreation officials.
